I am afraid that we will need some idea on the flight path. That is what you are going to film when flying the drone and in what type of area you would take of and land for example.

Keep in mind that you can change your mind about the flight path and let us know if you want to do some changes. We or the rangers in the area will let you know if the changes are ok or not. We just need to know what you want from the droneflight so we can see if it is ok or not. You would need to inform the rangers in the area about your arrival in some advance before you enter the area and if you have questions you can always ask them.

Hi Thordis,

Thank you for your response.

We plan to fly the drone over the three locations you mention : Strýtan, Geysir and Mývatn. Claudia can confirm where exactly we plan to film on the lake, but in general we would like to fly over all of those areas if possible.

We are following, and plan to adhere to all of the Icelandic Transport Authority's regulations when it comes to flying our drone, so won't be flying higher than 120m above ground or sea. We are using the document attached provided by the Icelandic Transport Authority as a guideline and will also be registering our drone ahead of our shoot.

If you could let us know any other regulations you have within these areas when it comes to filming please let us know and we will be happy to comply. As we won't be coming to the location before we come over to film in March, it is difficult to provide an exact flight path but we aim to fly over those main areas we have listed.

If you can let us know what other information you need from us in order to grant filming permission for these locations that would be great. We are a small documentary crew, and aim to work alongside yourselves to ensure we adhere to all protocols necessary and treat the areas with the highest level of professionalism and respect.

I am also happy to discuss this further with you on the phone if that is more convenient.
